Emotional: *Horses don't judge; they are present & willing. Principles of inclusion, non-discrimination & team work are emphasized.*

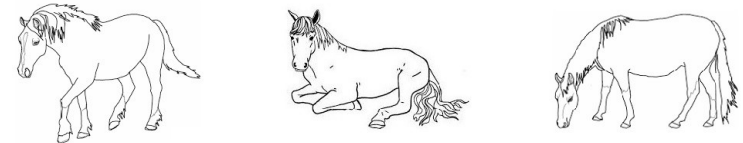
